Student Contract Terms & Conditions 2024/25

1. Introduction

- 1.1 This document governs the relationship between you and BIMM Group Limited ("BIMM University" or "we" or "us" or "our") and sets out the contract terms between us for the provision of educational services leading to the opportunity to gain a recognised educational qualification (the "Terms and Conditions"). These Terms and Conditions contain important information and should be read carefully before you accept a place at BIMM University.
- 1.2 BIMM Group Limited is a private company limited by shares incorporated in England and Wales with registered number **07172561** and its registered office is at 38-42 Brunswick Street West, Hove, East Sussex, United Kingdom, BN3 1EL. [BIMM Group trades as BIMM University.]
- 1.3 These Terms and Conditions apply following acceptance of an offer of a place at BIMM University, Berlin.
- 1.4 In addition to this document, the following documents also form part of the Terms and Conditions and in accepting an offer from BIMM University, you agree to observe them:
 - 1.4.1 your offer letter;
 - 1.4.2 the Applicant Course Overview for your course (which will be sent to you with your offer letter) and subject at all times to clauses 1.5 and 11, as it may be updated from time to time by us;
 - 1.4.3 the "Important Regulations and Information" document (which will be sent to you with your offer letter) and subject at all times to clauses 1.5 and 11, as it may be updated from time to time by us; and
 - 1.4.4 BIMM University's policies, guidance, and information regarding international students (details of which will be sent to you with your offer letter, if applicable) and subject at all times to clauses 1.5 and 11, as it may be updated from time to time by us.

Together these documents form the contract between you and BIMM University in relation to your course (the "Contract").

- 1.5 We will always inform you directly via email of any changes to the Applicant Course Overview or the Important Regulations and Information and we will endeavour to do this before teaching starts each academic year.
- 1.6 It is important that you read, and abide by, the <u>Important Regulations and Information</u> document. This highlights and signposts you to BIMM University's <u>rules</u>, <u>regulations and</u>

<u>policies</u>. It also illustrates your responsibilities as a student of BIMM University, and our responsibilities to you as a provider of educational services.

- 1.7 If there is any conflict or inconsistency between any of the provisions in these Terms and Conditions and the provisions of any other document forming part of the Contract the provisions of these Terms and Conditions shall prevail.
- 1.8 The Contract is subject to these Terms and Conditions and is created once you accept the offer.

2. Accessibility

- 2.1 BIMM University is committed to providing an inclusive and accessible environment and strives to make reasonable adjustments to accommodate the needs of its students. Students and applicants with disabilities are encouraged to notify BIMM University at the earliest opportunity so that (if possible) appropriate support arrangements can be provided.
- 2.2 Should you require these documents in another format, or if there is anything in these Terms and Conditions that you do not understand, please contact admissions@bimm-institute.de.

3. Offers & Registration

- 3.1 By accepting an offer of a place at BIMM University, you are entering into an agreement with us in accordance with these Terms and Conditions.
- 3.2 Your admission to BIMM University is subject to you complying with the terms of the Contract. If you do not act in accordance with the Contract, or if you do not meet our expectation that you will maintain a standard of conduct, as specified in the Student Code of Conduct, which is not harmful to the work, good order or good name of BIMM University, we may take disciplinary action against you under the Student Disciplinary Procedure. One of the possible outcomes of such an action is that your Contract with us may be terminated in accordance with clause 10.1 below and you may be removed from your course.
- 3.3 The offer we make to you is subject to you satisfying all necessary legal and academic requirements for admission set out in your offer letter. The offer may be conditional or unconditional. If the offer is conditional, we will set out the conditions you need to fulfil in order to be admitted to the course, in your offer letter. If you have not fulfilled the conditions of your offer before the date notified to you in the offer letter prior to the start of the course, we reserve the right to withdraw the offer.
- 3.4 It is important that you provide accurate information in your application to study at BIMM University. We may withdraw or amend any offer, without liability to you, if we discover that your application contains material inaccuracies or fraudulent information (including fraudulent

payment), or if you are found to have provided misleading information or omitted key information from your application.

- 3.5 At our request, you will provide satisfactory evidence of your qualifications (including English language qualifications if required) before admission. Failure to provide such evidence to our reasonable satisfaction before the date notified to you will result in the withdrawal or termination of your offer, the revocation of your registration as a student of BIMM University and/or the termination of the Contract. We will verify the authenticity of documentation required to evidence your qualifications prior to admission as appropriate. You must complete your registration by the end of Week 3 in Semester 1. You will not be able to enrol and commence your studies if you have not met the entry requirements set out in your offer letter, and if you have not provided certificates/proof of qualifications obtained or payment of fees/confirmation of your student loan.
- 3.6 If BIMM University withdraws your application, offer, or refuses to enrol you pursuant to clauses 3.3, 3.4 or 3.5, BIMM University reserves the right not to refund any tuition fees paid and/or deposit (if applicable).

4. Your Right to Cancel

- 4.1 You have the right to cancel the Contract with BIMM University for any reason within fourteen (14) days after the date on which you accepted the offer of a place to study at BIMM University, Berlin (the "Cancellation Period").
- 4.2 To cancel the Contract, you must give us written notice of your cancellation by contacting admissions@bimm-institute.de. You can use our Cancellation Form but you do not have to do so.
- 4.3 If any payment has been made to us and you subsequently cancel the Contract pursuant to your right to cancel as set out in clause 4.1, we will provide you or the person who has made such payment (as the case may be) with a full refund of tuition fees and/or deposit (if applicable) using the same payment method that was used to make the payment. Such refund will be made no later than fourteen (14) days after the date on which you informed us of your decision to cancel the Contract.
- 4.4 If your course is due to begin within the Cancellation Period (for example, if you have applied through clearing) then, by accepting your offer, you are expressly agreeing that the course should begin within the Cancellation Period. If you then decide to withdraw from your course within the Cancellation Period you may be liable to pay a proportion of your tuition fees, as set out in clause 9.4.
- 4.5 You may terminate the Contract after the expiry of the Cancellation Period but, in such case, you must do so in accordance with clause 9 of these Terms and Conditions. Depending on when

you cancel the Contract (in particular whether it is before or after registration) you may be obliged to pay a proportion of your tuition fees. Further details are set out in clause 9.4.

5. Your Obligations

- 5.1 You agree to fulfil all the academic requirements of your course in accordance with the Contract, including, but not limited to, submission of course work and other assignments, attendance at examinations, attendance at lectures and seminars and any other such teaching forums provided by us.
- You agree to familiarise yourself with and adhere to BIMM University's rules, regulations and policies. These are all published <u>on our website</u>, and you can also access them directly from the <u>Important Regulations and Information</u> document.
- You agree to comply with our <u>Student Charter</u>, our <u>Student Code of Conduct</u> and the policy on Academic Integrity. Links to all of these documents are set out in the <u>Important Regulations</u> and <u>Information</u>.
- If you are from a country outside of Germany, you shall maintain and evidence an immigration status that entitles you to undertake your course and you also agree to comply with BIMM University's policies, guidance and information regarding international students that can be accessed here.

6. Our Obligations

- 6.1 We shall deliver your course with reasonable care and skill and as described in the relevant course prospectus in all material respects. The method of delivery for your course will be stated in your offer letter. If we have to change the method of delivery of your course during an academic year, this may constitute a change to your course. Please see clause 11 for further details.
- 6.2 We shall provide you with tuition and other teaching and learning support and resources associated with your course with reasonable care and skill and we shall provide you with timely feedback on your academic work.

7. Right to Study for International Students

- 7.1 All students enrolled at BIMM University must have the right to study their course in Germany and hold valid immigration status confirming that you have the right to study throughout your course (as applicable).
- 7.2 If you are a student from outside the European Union applying to study at BIMM University, Berlin, you will need to demonstrate at the point of registration (also known as enrolment) that you have a valid immigration status to undertake your course. A valid 'immigration status' includes a study visa issued by the German Embassy/ Foreign Office, or an already established

Aufenhaltserlaubnis (limited)/ Niederlassungserlaubnis/ Erlaubnis zum Daueraufenthalt-EU (permanent), in which case you will not require a visa.

- 7.3 We will request evidence showing your valid immigration status during the application process. If you fail to provide such evidence to us within a reasonable timeframe, we reserve the right to prevent you from registering on your course (without liability to you) or withdraw you from your course in accordance with clause 3.3 and 10.1.6.
- 7.4 If you require a visa or permission to stay in Germany to study at BIMM University, it is your responsibility to obtain the appropriate status before commencing your course. By agreeing to these Terms and Conditions, you also agree to abide by the terms and conditions of your immigration permission throughout the course.
- 7.5 International students are advised to apply for visas in good time and a colour copy of such visas must be provided prior to registration. Please note that the German Foreign Office (Landesamt für Einwanderung) advises that there is a process time of 25 days from the point of your visa application, however we advise allowing at least 90 days for the turnaround of your visa application as the German Foreign Office can experience high demand in the lead up to semester start dates. To apply for your student visa, you will need proof of acceptance of study at BIMM University. The BIMM University Germany Admissions Department can issue this to you on acceptance of your offer of study and payment of your deposit.
- 7.6 You will not be liable to pay the course tuition fees if a visa is not granted by the German Mission (Embassy), preventing your enrolment at BIMM University.
- 7.7 You must inform BIMM University immediately if there are any changes whatsoever to your details or immigration status, or any other circumstances, at any time before or after registration, and during your course.
- 7.8 For the avoidance of doubt, BIMM University shall not be responsible for any changes in immigration legislation which result in you no longer being eligible to study at BIMM University.
- 7.9 For further details, please see BIMM University's <u>Admissions Policy</u>.

8. Tuition Fees & Funding

- 8.1 The tuition fees and any deposit applicable to your course and information in relation to how to pay for your course, or for modules/units within it, are set out in your offer letter, offer pack and the Important Regulations and Information document.
- 8.2 There may be additional costs relating to your course which you agree to pay to BIMM University or to a relevant third party (as appropriate). Additional costs include, but are not limited to, costs relating to musical instruments, musical equipment, computers, IT equipment, hiring of music studios and other venues, compulsory texts, materials, printing

costs and field trips. Where this is the case, we will make this clear in advance as part of the information provided to you when you are made an offer and on our website https://www.bimm-institute.de/essential-documents/.

- 8.3 The amount of any deposit you must pay will be set out in your offer letter. Deposits will be non-refundable except where:
 - 8.3.1 a visa is not granted due to an error in the supporting evidence (proof of study document) provided to you by BIMM University in support of your visa application;
 - 8.3.2 you are an international student and are unable to obtain a student visa necessary to study on the course and BIMM University is satisfied that you took all reasonable steps to ensure you obtained your visa prior to commencing your course and that the failure to obtain the visa was not your fault;
 - 8.3.3 you cancel your acceptance of a place within the Cancellation Period (see clause 4.1); or
 - 8.3.4 your application or your offer is withdrawn by BIMM University in accordance with clause
- 8.4 If you accept an offer, you agree to pay all tuition fees (including any deposit) and additional costs as and when they fall due, in accordance with your offer letter, offer pack and the Important Regulations and Information document.
- 8.5 If you are required to pay a deposit, and you are unable to pay your deposit at the point of acceptance of your offer of study at BIMM University, Berlin, then your deposit must be paid at the time you accept your offer.
- 8.6 If you do not pay a deposit at the time of accepting your offer, we will be unable to guarantee your place of study on your chosen programme, and we may offer the place on your chosen course to another applicant. BIMM University's Admissions Department will advise you of this. If there is no longer availability on your chosen study programme, then you may be advised to apply for an alternative course of study or re-apply for a future academic year.
- 8.7 If your tuition fees are being funded, proof of student loan or other funding body's acceptance of funding for the tuition fees, together with the extent of funding provided must be received by BIMM University on or before 15th September immediately preceding the start of the academic year, otherwise you may not be able to take up your place on the relevant course.
- 8.8 If you do not intend to apply for, or are not eligible for, a student loan/ grant (via a funding body), full payment of the tuition fees for your course must be received in cleared funds by BIMM University on or before 15th September immediately preceding the start of the academic year, otherwise you may not be able to take up your place on the relevant course.
- 8.9 If you decide to study at BIMM University, Berlin after 15th September, and there is still availability on your chosen academic programme, our Finance Department will contact you to arrange your deposit and tuition fee payment at the time that you accept your place of study.

- 8.10 In the event that a third-party sponsor has agreed to pay all or part of your tuition fees, you remain primarily liable for the payment of the tuition fees, and you should make arrangements to ensure that the tuition fees have been paid by your third-party sponsor.
- 8.11 Tuition fees are due for each full year of attendance.
- 8.12 Details of your tuition fees for the first academic year of the course will be set out in your offer letter.
- 8.13 Tuition fees for subsequent years of your course may be different from those set out in your offer letter, but will be no higher than [10%] of your current tuition fees. We shall notify you of any increase to your tuition fees no less than three (3) months before the start of the academic year to which the tuition fee increase is intended to apply. Such notice shall include details of why BIMM University if intending to increase your tuition fees.
- 8.14 If we choose to increase your fees, we will be doing so for one or more of the following reasons:
 - 8.14.1 a requirement to further invest in BIMM University's estate/ facilities;
 - 8.14.2 a requirement to enhance the quality of the student learning experience; or
 - 8.14.3 in order to manage inflationary rises in operational costs.
- 8.15 If you are unhappy with the increase in tuition fees, you may terminate the Contract and/ or withdraw from the course without incurring any liability to us for the increased tuition fees by giving BIMM University notice in accordance with clause 9.2.
- 8.16 Unless otherwise agreed by us, all fees must be paid by the deadline set out in these Terms and Conditions. We reserve the right to charge interest on a day-to-day basis on tuition fees and other amounts due which are unpaid after such time. BIMM University accepts no liability for bank or card charges incurred by you. You must pay the full tuition fees stated without any deductions.
- 8.17 If you take a break from your studies or otherwise defer your course or you are required to repeat part or all of your course, the tuition fees charged will be the tuition fees payable for the year that you return to your course or that you repeat (as applicable).
- 8.18 You are responsible for knowing the exact source of funding of your tuition fees and any applicable VAT or equivalent sales tax. Where unauthorised funds are received into BIMM University's bank account, or where you fail to provide satisfactory information about the payer, then for compliance reasons (including in relation to the Proceeds of Crime Act 2002 or any such similar applicable legislation) BIMM University may return funds back to the payer, and you will be required to make payment (from a bank account in your own name) to BIMM University immediately. Any return of funds may potentially result in a financial loss to you

- and/ or the payer due to currency exchange losses and/ or bank handling fees which BIMM University shall accept no responsibility for.
- 8.19 Where a debit or credit card payment received by BIMM University is subsequently disputed by the cardholder and BIMM University agrees to return the funds back to the payer, if there is a tuition fee balance owing, you will be required to make payment to BIMM University immediately.
- 8.20 If you fail to pay your tuition fees as and when they fall due, we reserve the right to withdraw you from your course (without further liability to you) and seek to recover any debts. You may not be allowed to register on your course or, if you have registered, your registration may be suspended or revoked entirely if your tuition fees remain outstanding after the deadline. If your registration is suspended or revoked, you will be prohibited from attending any premises of BIMM University and you will not be permitted to sit examinations, submit assignments, attend classes, access library or computing facilities, or access student records. We reserve the right to refuse progression to subsequent years of study relevant for your course, withhold your results and we will not issue any course certificates or awards to any student who has not paid their tuition fees in full.
- 8.21 Any claims for refunds and compensation will be processed in accordance with these Terms and Conditions and our <u>Student Protection Plan</u>. Any refunds and compensation will be payable in accordance with the original payment method.

9. Withdrawal, Deferral & Intermission

- 9.1 You may withdraw from BIMM University and terminate your registration and the Contract at any time. On termination of your registration in accordance with this clause 9, you may remain liable to pay your tuition fees and any other amounts due, pursuant to clause 9.4.
- 9.2 To withdraw from BIMM University you must complete and submit a Withdrawal Form, which is available from your Student Wellbeing Team. Notice shall take effect on submission of the Withdrawal Form.
- 9.3 For the avoidance of doubt, "Withdrawal" is to leave the course for reasons other than those related to clauses 8.14 (increased fees) or clauses 11.1 to 11.6 (changes to courses and modules), without the intention of returning in the future. "Deferral" is a temporary postponement of studies from the end of one academic year to the beginning of another (taking a year out of your studies). Deferral is normally only permitted for one academic year. Further information is set out in the Academic Regulations (see also the Important Regulations and Information document).
- 9.4 If you Withdraw from your course during the Cancellation Period (but have received teaching during the Cancellation Period) or after the Cancellation Period has expired, your fees will be revised based on the date you withdraw, as set out in the table below:

- 9.5 For the avoidance of doubt, "Intermission" is a period of temporary postponement of studies from an agreed point in one academic year to the same point in the next academic year. Intermission is normally only permitted for a maximum period of twelve months. In the event of Intermission, no refund or part refund of the tuition fees will be given. Liability for any tuition fees not received (through any funding body, or otherwise unpaid) will be determined by BIMM University and notified to you in writing. You will be required to pay full tuition fees in the academic year in which you return.
- 9.6 If BIMM University sponsors you under the sponsored student route (if applicable), withdrawal, deferral or intermission may have an impact on your sponsorship and you should contact immigration@bimm.co.uk before taking any action.

10. BIMM University's Right to Terminate

- 10.1 BIMM University may withdraw your offer and/ or terminate your Contract and withdraw you from your course if:
 - 10.1.1 you do not pay the tuition fees in accordance with these Terms and Conditions;
 - 10.1.2 you have failed to meet the conditions of your offer;
 - 10.1.3 you do not complete your registration at the beginning of the course, or you fail to reregister at the beginning of an academic year;
 - 10.1.4 you have provided false, incomplete, inaccurate or misleading information in your application to BIMM University or at any other time;
 - 10.1.5 you fail to provide satisfactory evidence of your qualifications before admission;
 - 10.1.6 you do not meet your obligations within your visa, or you no longer have permission to study in Germany;
 - 10.1.7 you have poor attendance at lessons and engagement with assessment (further details set out in the Student Engagement Policy);

- 10.1.8 you fail to meet the progression requirements and have exhausted opportunities to retrieve credit;
- 10.1.9 you are found guilty of a serious breach of our regulations at a disciplinary hearing;
- 10.1.10 a fitness to study panel finds that you are unable to continue your studies due to illness, including mental health issues;
- 10.1.11 you exceed the maximum registration period for your course;
- 10.1.12 you fail to return after a period of Intermission or Deferral;
- 10.1.13 you are found guilty of academic misconduct;
- 10.1.14 you do not comply with the <u>Student Code of Conduct</u>, and we take disciplinary action against you under the <u>Student Disciplinary Procedure</u>; or
- 10.1.15 you fail to comply with your obligations under these Terms and Conditions in any material respect.
- 10.2 BIMM University will not terminate this Contract without good cause and consultation with you. Provided any action is taken to terminate the Contract in accordance with our <u>policies and procedures</u>, we shall not be liable for any loss or damage which you may suffer as a result. Depending on the circumstances we may also be entitled to take legal action against you.
- 10.3 On termination of the Contract by BIMM University you are liable for any outstanding tuition fees for the year and any other amounts due.

11. Changes to Courses & Modules

- BIMM University makes every effort to ensure that the information provided to you about your course is correct, and that we do not omit informing you about important information that might affect your decision to study at BIMM University. Due to the time period between prospectus publication and registration on your course, circumstances may change due to factors beyond our reasonable control and therefore it may sometimes be necessary to vary the content of the course or modules or services (including the mode of delivery) as described in the prospectus (at the date of your offer letter), or cancel a course in its entirety. We will use reasonable endeavours to ensure that changes are kept to a minimum, but if we need to make any material changes to your course (as described in your offer letter and/ or relevant prospectus) before you register at BIMM University, we shall bring the changes to your attention as soon as possible. If you reasonably believe that the proposed changes will have a material prejudicial effect on you, you may either terminate the Contract and/or withdraw your application for the course without any liability to us for tuition fees, or transfer to another course (if any) as may be offered by us for which you are qualified.
- 11.2 BIMM University's <u>Student Protection Plan</u> sets out what you should expect to happen should your chosen course or BIMM University closes, including arrangements that would be put in place to enable you to complete your studies.

Changes to your course prior to your registration as a student

- 11.3 We will use reasonable endeavours to deliver all courses as described in the relevant prospectus (at the date of your offer letter). However, BIMM University may in some circumstances be required to postpone the start date or cancel a course, for example (without limitation): if there are insufficient student registrations to make a course viable, where a key member of staff is no longer available (e.g. through illness or resignation), if suitable alternative teaching or supervision cannot be provided, where a course is required to be cancelled due to a commercial reason, or as a result of factors beyond our reasonable control. If you have received an offer for any course described in the prospectus, but we discontinue the course prior to you registering at BIMM University, we will notify you as soon as possible and we will use reasonable endeavours to offer you a place on a suitable replacement course for which you are qualified. If you are unhappy with the replacement course offered by us or if we are unable to offer a suitable replacement course, you may terminate the Contract and/or withdraw your application for the course without any liability to us for tuition fees.
- 11.4 If you agree to transfer to such other course as may be offered to you by BIMM University (and for which you have the necessary qualifications), you will be liable for any variation in fees (tuition and any additional cost) between the original course (which is no longer available to you) and the replacement course you have agreed to transfer onto. This may result in you being required to pay more or less for your replacement course than for your original chosen course of study.

Changes to your course after registration as a student

- 11.5 Once you have registered as a student of BIMM University we will use reasonable endeavours to deliver your course in accordance with the Contract. However, if we need to discontinue your course because of matters beyond our control or other significant reasons which may include (without limitation): insufficient student registrations, financial viability of the course or where we cannot guarantee the delivery of a high quality academic course and/or student experience), we will inform you as soon as is reasonably practicable and will use reasonable endeavours to transfer you to a suitable replacement course for which you are qualified. If you are unhappy with the replacement course offered by us or if we are unable to offer a suitable replacement course, you may terminate the Contract and/or withdraw from the course by giving BIMM University notice in accordance with clause 9.2 and without incurring any further liability to us for tuition fees. You shall be entitled to a refund of all tuition fees paid to date.
- 11.6 Following suitable consultation with affected students, in circumstances where it is necessary to make a material change to your course (such as the nature of the award, a material aspect of the curriculum, changes to the educational purpose of a course or changes to the mode of delivery of a course), we will notify you as soon as possible. If you are unhappy with the material change(s) to your course, you may terminate the Contract and withdraw from the course by giving BIMM University notice in accordance with clause 9.2 and without incurring any further liability to us for tuition fees and you shall be entitled to a refund of all tuition fees paid to date.

- 11.7 We reserve the right to vary minor elements of your course from that described in the prospectus and/ or your offer letter. Minor variations may include changes of module title, changing a module from compulsory to optional as well as minimal variations to module content. Such minor and material variations will be made to improve the quality of educational services and ensure the student experience; to meet the latest requirements of a commissioning or accrediting body in response to student feedback; to respond effectively to, or as a result of academic staffing changes, changes to BIMM University's regulations, a lack of student demand for certain modules, operational or academic changes; to comply with Government guidance; or as a result of factors beyond our reasonable control. How we notify you will depend on the nature of the changes but, in any event, such changes will be published in the updated course information on our website.
- 11.8 The option modules available on your course are subject to variation dependant on minimum numbers of students (normally 15) for each module and the availability of expert staff and module specific resources at BIMM University, Berlin. We will ask you to choose your option modules towards the end of the academic year during the first and second years of your course and you may be required to choose new option modules if any that you have selected will not be available. Once this process is completed, we will confirm your final options to you in writing.
- 11.9 If you choose to cancel the Contract in accordance with clauses 11.1 to 11.6 we will use reasonable endeavours to assist you in finding an alternative comparable course with another Higher Education provider.

12. Online provision of courses

- 12.1 If, and to the extent that any part of the course is delivered online as per your offer letter, or if we are forced to move to an online delivery mode due to factors beyond our reasonable control, then the following provisions of this clause 12 shall apply.
- 12.2 If any part of the course is delivered online, it shall be delivered using BIMM University's virtual learning platform (Canvas). When you register to access our virtual learning platform for the first time, you may be required to accept the platform's terms of use. We will provide you with information on how to access the virtual learning platform prior to commencement of the course.
- 12.3 You will only be allowed to use the content of the virtual learning platform for your own personal learning and will not be allowed to adapt it, or use it for any other purpose other than your own learning in relation to your course. You are not permitted to distribute any content to anybody else or to use the virtual learning platform for any other purpose.

- 12.4 The costs of any equipment and internet access required for the online provision of any part of your course is not included in the fees and this will be your responsibility. You will also be responsible for checking any materials, equipment and other devices intended to be used for the online provision of any part of your course is compatible with the specification requirements of the course.
- 12.5 BIMM University will use reasonable endeavours to provide for the online delivery of any part of your course (as may be required) but cannot guarantee uninterrupted, timely or error-free availability or that defects will be corrected. BIMM University may suspend access to the virtual learning platform for the provision of online delivery of any part of your course for the purposes of scheduled or emergency maintenance, repairs or upgrades to improve the performance or functionality of the virtual learning platform. BIMM University will use reasonable endeavours to provide you with reasonable notice in the event of any suspension or withdrawal of the virtual learning platform of which BIMM University is aware. Providing BIMM University has complied with the provisions of this clause 12.5, BIMM University will not be held responsible for any technical problems you encounter following the provision of online delivery of any part of your course, and accepts no liability to the extent there are errors, defects, interruptions and periods of suspension relating to the virtual learning environment.
- 12.6 You should keep separate copies of any work uploaded to the virtual learning platform as part of the provision of online deliver for any part of your course. To the extent permitted by law, BIMM University accepts no liability whatsoever for any loss, destruction or corruption of data or content uploaded to the virtual learning platform.

13. Liability

- 13.1 Subject to the remainder of this clause 13, BIMM University (including its staff and/ or representatives) shall have no liability to you for any loss, damage, costs or expenses arising under or in connection with the Contract except where such loss or damage is directly caused by BIMM University (or its staff or representatives). BIMM University shall not be liable for any loss or damage which was not foreseeable. Losses are foreseeable if they are an obvious consequence of BIMM University's breach of the Contract.
- 13.2 Where such loss or damage is directly caused by BIMM University (or its staff or representatives), BIMM University's liability shall, subject to clause 13.5, be limited to 100% of all tuition fees paid or payable by you to BIMM University.
- 13.3 While we take reasonable care to ensure the safety and security of students at our colleges, we cannot accept responsibility and expressly exclude liability for loss or damage to students' personal property (including but not limited to computer and IT equipment, software, bicycles

and vehicles), including any financial or other consequential loss where such loss or damage is a result of theft, fire, flood, computer virus or any cause related to our computer facilities, or any other cause, except where such loss or damage is caused by our negligence. It is recommended that you insure personal property against such risk of loss and damage.

- We shall not be held responsible for any injury to a student, financial or other loss or damage resulting from such injury, or for damage to property, caused by any other student, or by any person who is not an employee or authorised agent of BIMM University.
- 13.5 Notwithstanding any other provision in the Contract, nothing shall exclude or restrict BIMM University's liability for death or personal injury resulting from its negligence or fraudulent misrepresentation or in any other circumstances where liability may not be limited under any applicable law.
- 13.6 We shall not be liable to you in any manner whatsoever for any failure or delay, or for the consequences of any failure or delay, in performance of our obligations under the Contract, if such failure or delay is due to any event beyond our reasonable control (including, but not limited to strikes, lockouts or other industrial action, acts of God, severe weather, natural disasters, pandemic, quarantine or widespread illness, war, protest, riot, civil disorder or unrest, fire, explosion, an actual, suspected or threatened act of terrorism, national emergencies, any restrictions imposed by government or public authorities, breakdown of plant or machinery, actions or default of placement providers or default of suppliers or subcontractors). In such circumstances, we shall take reasonable steps to minimise any disruption to students, which may include (but is not limited to) the following:
 - 13.6.1 altering timetables to reschedule classes;
 - 13.6.2 changing elements of the course to enable us to deliver; and
 - 13.6.3 changing the delivery method or delivery location of the course.

14. Intellectual Property

- "Intellectual Property Rights" means any patent, rights to inventions, copyright and related rights, performers' property rights, trademarks, trade names, domain names, rights in get-up, goodwill and the right to sue for passing off or unfair competition, rights in designs, rights in computer software, database rights, rights to preserve the confidentiality of information, and other intellectual property rights, in each case whether registered or unregistered and including all applications (or rights to apply) for and be granted, renewals or extensions of and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which may now or in the future subsist in any part of the world.
- 14.2 Any Intellectual Property Rights developed by you during your course of study at BIMM University shall be governed by the <u>Student Intellectual Property Policy</u>.

By registering on a course, you authorise BIMM University and any associated company to publish photography, video content and any other materials produced by you relating to your course of study with BIMM University in all territories for the purposes of publicity and promotion without restriction.

15. Complaints

- 15.1 If you have a complaint about an admissions decision or an aspect of the admissions process, please follow our Applicant Complaints Procedure.
- Once you have registered as a student of BIMM University, if you have a complaint about us, please follow the Student Complaints Procedure. This is detailed here and can also be accessed from the Important Regulations and Information document. If, having followed the complaints procedure to completion, you remain dissatisfied you have the right to make a complaint to the Office of the Independent Adjudicator for Higher Education.

16. Data Protection

- 16.1 We will process your personal data in accordance with the General Data Protection Regulation (GDPR) and our <u>Data Protection Policy</u>. This can also be accessed from the <u>Important Regulations and Information</u> document. We may share your personal data with third parties, which we will do in accordance with our policy on data protection.
- Once you are registered as a student of BIMM University, we are required to collect and provide information to certain external agencies including the Higher Education Statistics Agency, whose data protection notice can be found here.
- After you complete your studies, we will retain basic registration details, results, any discipline records and your address, and any information that may be required in relation to matters that are still outstanding. Basic information will also be passed to our Development and Alumni Relations Office to create an alumni database. The remaining information will be destroyed.

17. General

- 17.1 The Contract constitutes the entire agreement between you and BIMM University and supersedes all previous agreements between you and BIMM University, whether written or oral.
- 17.2 The Contract is personal to you, and you may not transfer any of your rights or obligations under the Contract to another person.

- 17.3 The Contract is between you and us and no other person shall have any rights to enforce any of its terms.
- 17.4 Each of the paragraphs of these Terms & Conditions operate separately. If a court decides that any of them is unlawful the remaining paragraphs will remain in full force and effect.
- 17.5 If we do not insist immediately that you do anything that you are required to do under these Terms and Conditions, or we delay in taking steps against you in respect of your breaking this Contract, that will not mean that you do not have to do those things and it will not prevent us from taking steps against you at a later date.
- Any notice given under the Contract shall be in writing. We shall send any notice to you either to your term-time address or your home address or by email to your BIMM University email address. Unless otherwise stated in these Terms & Conditions, you must send any notices by email to financeenquiries@bimm.ac.uk marked for the attention of the Chief Finance Officer.
- 17.7 The Contract and any dispute or claim arising out of or in connection with it shall be governed by English law and you can bring legal proceedings in the English courts. If you live in Scotland, you can bring legal proceedings in either the Scotlish or the English courts. If you live in Northern Ireland, you can bring legal proceedings in either the Northern Irish or the English courts.
